## Farmhouse Omega Young at Heart Contest

### HOW TO PARTICIPATE

## Peraduan “Young at Heart” FARMHOUSE® Omega

### CARA-CARA PENYERTAAN

- Langkah 1: Beli FARMHOUSE® Omega (“produk”) dalam masa Tempoh Peraduan dan simpan resit asal sebagai bukti pembelian (“Bukti Pembelian”).
